

## CONTRACT FOR GAS SUPPLY

**AND WHEREAS** the **consumer** has agreed to be bound and the **Company** has agreed to supply the said premises with natural gas in accordance to the “**General Terms and Conditions of Gas Supply**”, as published by the **Company** including any subsequent amendments thereto.

**NOW THIS AGREEMENT WITNESSETH** as follows: -

1. In accordance to the “**General Terms and Conditions of Gas Supply**”, the **consumer** shall pay a sum of Malaysian Ringgit \_\_\_\_\_

as collateral deposit payment for which shall be in cash and or in the form of bank guarantee acceptable to the **Company**.

2. Whenever the **Company** is under constraint to amend the “**General Terms and Conditions of Gas Supply**”, a general notice in writing shall be served to the **consumer**. Such notice shall, without more, effectively amend the said “**General Terms and Conditions of Gas Supply**” so as to bind both the **consumer** and the **Company** to the same.

3. This **agreement** shall continue to be in force until such time as it is determined by a notice served on either party in the case of the **consumer** in accordance with Clauses 16 of the “**General Terms and Conditions of Gas Supply**”, and in the **Company’s** case on a 30 day’s written notice served on the **consumer**.

4. The **Schedule to this Contract Form**, the “**General Terms and Conditions of Gas Supply**” and the “**Guarantee for Payment of charges for Gas Supply**” shall form part of and be read and construed together with this Agreement.
